The Australian Native Garden - a Jewel in the Crown of the Royal Park

Behind the screen of trees along Gatehouse Street and Royal Parade, Parkville, there lies one of Melbourne's few urban indigenous gardens - the Australian Native Garden (ANG). By the early 1970s, this area had become the site of a council workers' depot with iron sheds littering the Park. Fortunately, a number of pre-settlement river red gums, originally on a creek through the park, survived the occupation, as did the historic Walmsley House. This had been used as a shed until "discovered" and saved from demolition by RPPG. It was later included on the State Heritage Register. Also saved was the nearby Golden Elm now on the Victorian significant tree register.

In 1974 a far sighted City of Melbourne administrator commissioned Grace Fraser, a well known landscape architect, to undertake a "*Study for the Australian Native Garden*". (Sadly Grace Fraser died earlier this year.) There was, at this time, an awakening of interest in Australian indigenous plants. Grace Fraser constructed the ANG as an informal garden where Melburnians could enjoy a display of native plant species and as an introduction for overseas visitors to the Australian landscape. Tullamarine Airport had just been opened and the Melbourne Council intended that visitors could take a quick trip around the ANG en route to the delights of the metropolis. Unfortunately Grace Fraser's plans were only partially implemented.

The 1987 Royal Park Master Plan provided directions for the restoration of Royal Park, including the ANG with indigenous bushland landscapes. The vision faded, however, when commissioners took over the City of Melbourne in the early 1990's and the revegetation of Royal Park was accorded a low priority. Kevan Gosper, Chief Commissioner, was responsible for clearance of 10 hectares of parkland around the Zoo, including avenues of Moreton Bay Figs and elms. Royal Park became progressively degraded. Revegetation only resumed when Councillors Martin Brennan and David Risstrom established an Implementation Committee to progress the projects established under the Royal Park Master Plan (revised in 1997.) A Vegetation Management Plan Sub Committee was formed with Council staff, landscape architects and horticulturists plus representatives of community groups - including the North and West Melbourne Association; the Parkville Association; and RPPG. This Sub Committee worked on the ANG intensively in keeping with the original vision of Grace Fraser. It was hoped that the regenerated ANG would encourage the return of birdlife with flocks of ibis and ducks at the billabong.

Unfortunately failure to control dogs and foxes in the Park has meant that wildlife has not been protected. After years of RPPG lobbying Council, a policy banning dogs in the ANG, together with other wetlands, was passed and it was finally gazetted in October 2010. Several years ago, the billabong was relined and a swale constructed through the ANG. Unfortunately under Lord Mayor John So, the Royal Park Committees were disbanded and so the community involvement in planning and oversight of changes in the Park has come to an end. The south garden bed on Gatehouse Street is soon to be replanted as the first part of a new regeneration plan.
